

The Department of Education has selected your 2019–2020 Free Application for Federal Student Aid (FAFSA) for review in a process called “Verification.” The law says that before awarding Federal Student Aid, your school may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information the Financial Aid Office will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences between your application information and your financial documents, Johnson or you may need to make corrections electronically or by updating your FAFSA. You must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the Financial Aid Office. Johnson may ask for additional information.

HIGH SCHOOL COMPLETION STATUS

Provide one of the following documents that indicates the student's high school completion status when the student will begin college in 2019–2020:

- A copy of the student's high school diploma.
- A copy of the student's final official high school transcript that shows the date when the diploma was awarded.
- A copy of the student's General Educational Development (GED) certificate, an official GED transcript that indicates the student passed the exam, or a state-authorized high school equivalent certificate.
- For students who completed secondary education in a foreign country, a copy of the "secondary school leaving certificate" or other similar document.
- An academic transcript that indicates the student successfully completed at least a two-year program that is acceptable for full credit toward a bachelor's degree.
- If State law requires a homeschooled student to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), a copy of that credential.
- If State law does not require a homeschooled student to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), a transcript or the equivalent, signed by the student's parent or guardian, that lists the secondary school courses the student completed and documents the successful completion of a secondary school education in a homeschool setting.

To Be Signed at the Institution

The student must appear in person at Johnson University to verify his or her identity by presenting a valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated with the date it was received and the name of the official at the institution authorized to collect the student's ID.

To Be Signed in the Presence of a Notary

If the student is unable to appear in person at Johnson University to verify his or her identity, the student must provide:

1. A copy of the valid government-issued identification (ID) that is acknowledged in the notary statement below, such as, but not limited to a driver's license, or other state-issued ID, or passport; and
